- 1. A statement of your account, payable at 415 South Frazier St., Conroe, Montgomery County, Texas will be furnished monthly. Terms of payment: Net 10th PROX. Any portion of the "Ending Balance" not paid within 30 days from the invoice date shall be considered past due and subject to a finance charge of 1.5% per month. Such rate will remain in effect until further notice to customer. Credit priveleges may be revoked at the discretion of Conroe Welding Supply on all past due accounts.
- 2. Undesignated payments received by Conroe Welding Supply on any past due account will be applied first to the finance charges due and the remaining amount to the discharge of the principal balance.
- 3. If it becomes necessary to enforce payment of any Sums due, through legal proceedings, customer agrees to pay all collection expenses including reasonable attorney's fees, court costs, and interest as allowed by law.
- 4. Customer acknowledges and agrees that all times the representative who signs on it's behalf, for all deliveries and returns of equipment or purchases, will have complete authority to act as the agent of customer.
- 5. Cylinders are the property of Conroe Welding Supply and customers agree that such cylinders shall not be loaned or transferred to another party without written consent from Conroe Welding Supply. Customer agrees to pay for all cylinders and equipment rentals, including all cylinders, fittings, or other equipment damaged or lost while in its posession at the current invoiced rates.
- 6. The undersigned guarantor (whether one or more), heirs, executors, and administrators, joined by the guarantor's spouse, if any, agree to unconditionally guarantee the entire above mentioned obligation of the purchaser named above (whether one or more), as a primary obligation and not secondary wherein this guaranty is payable and performable in County, Texas, with 18% interest on all past, present and future amounts due or the maximum interest allowed by law, whichever is smaller, plus reasonable attorney's fees and court costs to sue the undersigned. The guarantor waives notice of sale and delivery goods, extension or rearragnement of payment terms, and of sale and any collateral under a security interest. Any guarantor may be sued without demand or joinder of any other guarantor or purchaser as to amounts owing by the above purchaser.
